- 5. Perform procedures, steps, and techniques for men's taper haircut/style.
- 6. Perform procedures, steps, and techniques for women's taper haircut/style.
- 7. Perform procedures, steps, and techniques for women's long layered haircut/style.
- 8. Perform procedures, steps, and techniques for men's and women's advanced haircuts/styles using variations of the basic cuts/styles.
