Course Description:

This is an introduction to college-level writing and essay formats. Students will develop critical reading and thinking skills while mastering the writing process and improving their abilities to write, revise, and edit essays.

Prerequisites: ENGL 099, or an ACT score of 18 or higher

On completion of this course, the student will be able to:

1. Use reading and writing for inquiry, learning, thinking, and communicating
2. Move productively among stages of a recursive writing process to draft, revise and edit college-level compositions
3. Write college-level essays that display clear theses and defend those theses with sufficient support developed from personal experience, class discussions, and outside sources.
4. Write essays that employ a variety of styles (e.g. descriptive, narrative, comparison-contrast, persuasive)
5. Integrate and document information at an introductory level
6. Write in standard edited English free from major errors in grammar, usage and mechanics.
