- 3. Write college-level essays that display clear theses and defend those theses with sufficient support developed from personal experience, class discussions, and outside sources.
- 4. Write essays that employ a variety of styles (e.g. descriptive, narrative, comparison-contrast, persuasive)
- 5. Integrate and document information at an introductory level
- 6. Write in standard edited English free from major errors in grammar, usage and mechanics.
